You agree this release is in effect as of immediately.</p> <p>Waiver of Legal Liability: You are agreeing to let your minor child engage in a potentially dangerous activity. You are agreeing that, even if the YMCA uses reasonable care in providing this activity, there is a chance of serious injury or death to your child by participating in this activity because there are certain dangers inherent top the activity which cannot be avoided or eliminated. By signing this form, you are giving up your child's right and your right to recover from the YMCA in a lawsuit for any personal injury, including death, to your child or any property damage that results from the risks that are a natural part of the activity.
